Ramp Information and Fee

- Ramp fee is for unlimited use of the boat ramp for the season but trailers may **NOT** be stored on club property at any time unless appropriate fee paid below. Members may launch boats and park car and trailer during the day on pool grounds. (**Trailer **MUST** remain hitched to vehicle and be parked in the upper GRASS parking area. **DO NOT PARK CAR AND TRAILER IN MARINA PARKING AREA****)
- Ramp only sticker must be affixed to trailer at all times. Ramp only sticker will have a cut corner. For members who have more then one boat/trailer, an extra sticker may be obtained.
